Pilot Field Planning Permission (and Tilekiln) is approved



On 1 June the Planning Committee considered the planning applications for a football stadium and two 3G pitches at Tilekiln and a housing development on the Pilot Field. PFARA has worked hard in recent months to compile a range of many valid reasons why these proposals should not go ahead. See our website for more details.

The Tilekiln decision was made first. Peter Bailey (Chair of PFARA) and Meya Evans (ward councillor for Tilekiln and Deputy Council Leader) both gave presentations against the proposal but it was approved unanimously following recommendation from the Planning Officer.

Similarly for the Pilot Field housing development proposal, presentations objecting to this were given by Peter Bailey and our two local councillors, Rob Cooke and Mike Turner. However again the proposal was recommended for approval by the Planning Officer and there was only one vote against it.

Hope is not lost

Despite these decisions, the council still must agree to sell the lands to the developers. Bearing in mind the statement from Paul Barnett (leader of the Council) before the local elections, namely that the decision had been made to keep both areas green in line with the Council's Green policy, this would be a major turnaround if they now decided to sell.

Helenswood/Mount Denys Site

As mentioned in previous newsletters, the Pinehill & Mount Denys site has been extended to include the strip of ex-Helenswood land that is not part of Flagship School. There are no current updates on this site beyond us having made enquiries of the Council about whether HBC has approached the Dept. of Education to request change of use of the land and how the site became placed on the Brown Field Site Register by HBC.

The timeline for the Hastings Local Plan, the document that outlines the Council's intended development sites, has been revised again by the Council. The Pre-submission Draft Plan, considering the January-March 2021 round of consultation, was due to be published in June 2022. It is now anticipated to be published, and consulted on, winter 2022/23. We will update you once this process moves forward.

Highways/Verges

At the request of PFARA, and with the help of Cllr Turner, an extra 'no HGV' vehicle sign has been placed at the junction of Ochiltree and Pilot Roads. This should reduce the number of HGV's unwittingly turning left out of Ochiltree and having to dangerously reverse once they find it impossible to navigate the unmade part of the road that meets with the Ridge.

We have made a request via Cllr Turner, and directly via HBC, that the strip of trees near the corner of Pilot and Ochiltree Roads be better, and more regularly, managed. During recent winds large branches fell onto Ochiltree Road and these are now piled up on the verge. No reply has been received from HBC/highways yet and we have followed this up with Cllr Turner and will update residents again in due course.
